Page 6, line 6, after “housing situation,” insert “including where the health and safety of children are jeopardized,”.

Page 17, line 18, after “other” insert “than”.

Page 39, line 20, before the comma insert “or at risk of homelessness”.

Page 52, line 5, after “(continuum of care funding)” insert “for any of the types of eligible activities specified in paragraphs (1) through (7) of section 423(a)”.

Page 52, lines 6 through 8, strike “unaccompanied youth who qualify as homeless under any Federal statute other than title I of this Act” and insert “youth defined as homeless under other Federal statutes”.

Strike line 20 on page 52 and all that follows through page 53, line 5.

Page 65, line 21, before “outcomes” insert “goals and”.

Page 72, line 13, strike “and”.

Page 72, line 15, after the semicolon insert “and”.

Page 72, after line 15, insert the following:

1 “(viii) for collaborative applicants that
2 have exercised the authority under section
3 422(k) to serve families with children and
4 youth defined as homeless under other
5 Federal statutes, success in achieving the
6 goals and outcomes identified in section
7 427(b)(1)(F);”.

Page 73, line 5, strike “and”.

Page 73, line 22, after the semicolon insert “and”.

Page 73, after line 22, insert the following:

8 “(v) whether the recipient proposes to
9 exercise authority to use funds under sec-
10 tion 422(k), and if so, how the recipient
11 will achieve the goals and outcomes identi-
12 fied in section 427(b)(1)(F);”.

Page 75, line 9, strike “, to the extent practicable”.
