### **HOUSE RESOLUTION 414 - BROWN v. BOARD OF EDUCATION**

The U.S. House recognized the 50th anniversary of the Brown v. Board of Education Supreme Court decision and encouraged all Americans to observe this anniversary with a commitment to continuing and building on the legacy of Brown.

### **TAX CREDIT ALLOCATION**

I am happy to announce that the Wayne County Community Development Entity will receive an allocation of \$27 million through the New Markets Tax Credit Program. These funds will assist Wayne County in providing favorable lending products to encourage development throughout the County and in Detroit's low-income neighborhoods. Investment targets include; industrial facilities, neighborhood commercial facilities, downtown redevelopment, low-income person entrepreneurship and small business development and for-sale housing development.
